INCIDENT MANAGEMENT

POLICY STATEMENT

Bay of Plenty District Health Board (BOPDHB) will comply with the New Zealand Health and Disability Services National Reportable Events Policy 2012. All healthcare incidents that occur within its facilities will be reported and responded to. This will include systems to identify healthcare incidents, effective reporting and investigation of those events and processes to ensure lessons are learnt and recommendations are actioned.

PURPOSE

- To provide a nationally consistent approach to the management of healthcare incidents in order that health practitioners, managers and staff respond effectively to all incidents that occur in the health and disability sector.
- To provide a transparent process for the, escalation, investigation and review of clinical and corporate incidents.
- To ensure that systems for identifying, reporting, and managing incidents are robust and consistent with quality improvement and risk management approaches and are appropriate to culture, values and behaviours.
- To identify and manage the underlying root causes of incidents based on the severity assessment code (SAC).
- To ensure through open disclosure that individual consumers are involved in and informed about the process.
- To ensure learning from incident management is shared and used to improve quality and safety for both consumers and staff.
- To reinforce line manager responsibility for managing incidents while maintaining organisational oversight of actions taken to improve quality and reduce risk.
